The Course:

This course is a survey course of current literature on different topics related to the interaction between demography and society. There is a long tradition in the study of these relationship, which could be traced back to Malthus, but which finds its first academic expression in Durkheim's seminal book *Suicide*. The course will focus on recent publications in Sociology's and Demography's top journals to provide students with an overview of the field, including topics of interest and dominant methodological approaches. The course has a fairly Western-centric bias, for two reasons: 1) the breadth of the field demands difficult decisions concerning topics; 2) both instructor and students are probably more acquainted with the West's socioeconomic and political conditions, which will help in the understanding and contextualization of the course material.

Logistics:

The course takes the form of a 3-hour seminar. In the first part of each session, the instructor introduces the topic. This is followed by a group discussion of the session's required text. The remaining of the session focuses on a topic chosen for debate (both theoretical and methodological). One or two students will be in charge of critically presenting the required texts for debate in class. This will be followed by guided discussion monitored by those presenting and based on questions they will have prepared. After the class, students in charge of the debate will have to submit a synthesis of the papers and a briefing of the discussion that took place in class.

Grading:

Grades will be passed on class attendance, participation, and presentations.
